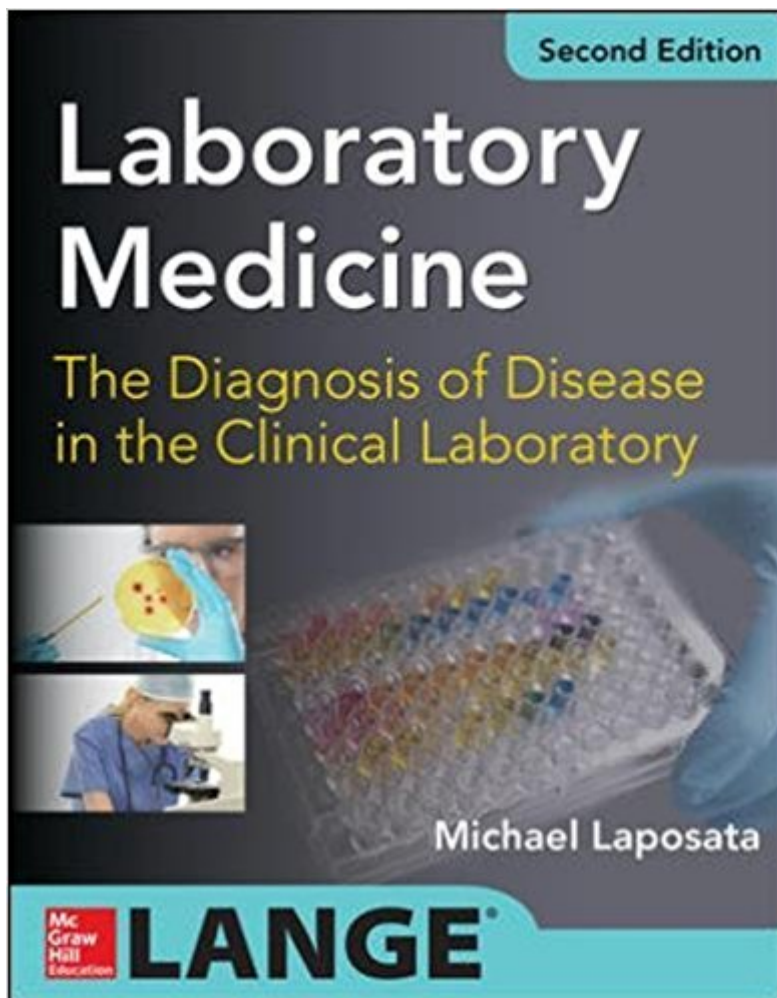

I think if you want cytogenetics on a broad scale it was great as it brought me ahead of the class before the chapters with it. Yeah guys rate me up, who gives you actionable details like that? Also, many topics include several pages of details it's not a laconic paragraph about something that is just generic pastiche it's a fairly in-depth (but not like Henry's which is like post-pathologist level half the time) resource that can help when combined with course materials if your teachers suck and don't even know anything about what they are teaching.
