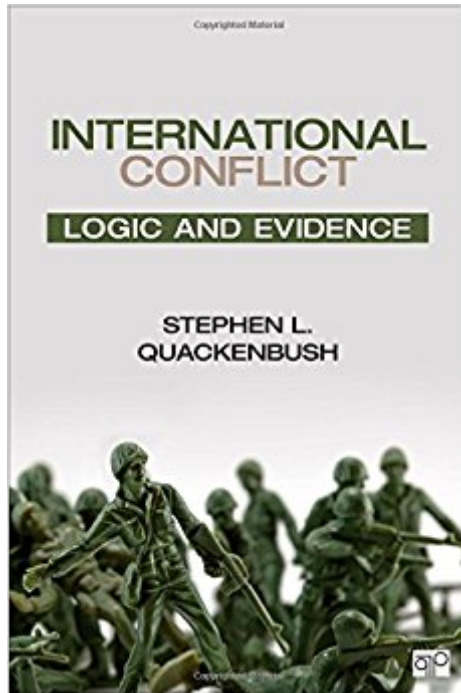

He served as an Army officer, including a year in Iraq in 2004, receiving the Bronze Star Medal.
