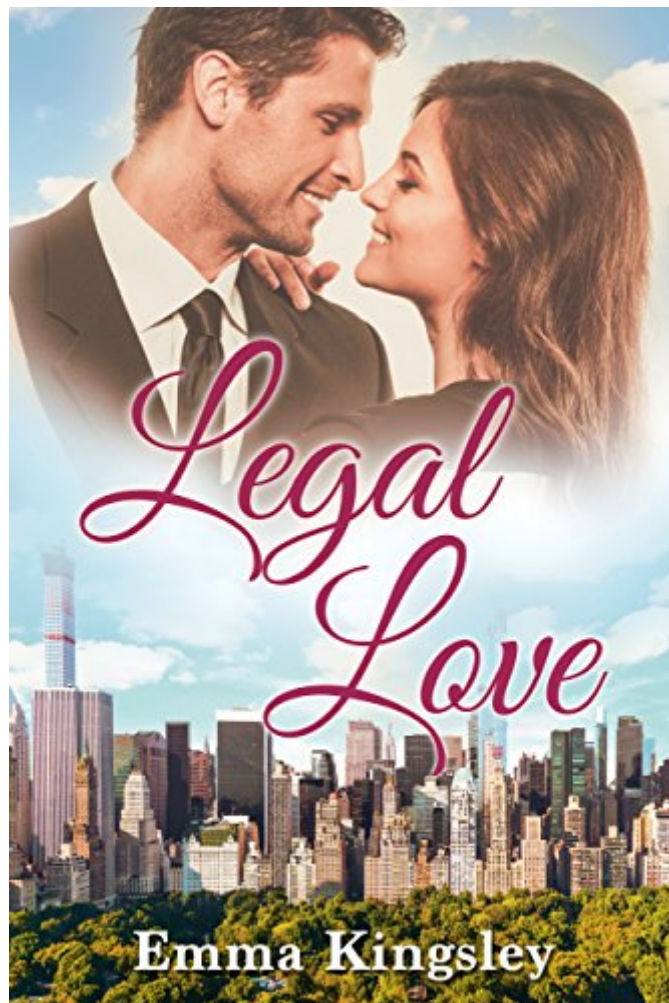

Emma Kingsley a new author has just written her first inspirational novel Legal Love. If this is an example of Ms. Kingsley work I can't wait to see what she next has in store for us. Legal Love is an emotional love story about ruthless billionaire Richard De Marco and his in house lawyer Grace Douglas. Grace would rather have had a job working at a non-profit environment firm but because she needs money to pay back her parents she is more or less forced to work for De Marco. Though they are night and day the chemistry between Grace and Richard is off the walls. How these two opposites reconcile their differences and achieve a happy-ever-after makes for great story. Legal Love is a real winner and I highly recommend reading it. I received this book from the author and I am freely posting this fair and balanced review.

Working at Richard De Marco's company is far from being lawyer Grace Douglas' ideal job. However, she really needs a job, and the pay is excellent. It doesn't take long for her to realize that people never stay with the company for long, nor for her to see why. Richard is not what one would call an ideal boss, but Grace figures she can stick anything out for a year. Richard, for reasons best known to himself, requires Grace's help a lot, and Grace soon begins to wonder if, perhaps, there's more to him than most people see. But, while Richard partly admires Grace and her willingness to stand up to him, he also believes that she has some hard lessons to learn. I appreciated the fact that, although Grace found herself attracted to Richard and wondering if he could be a better man than he showed most of the time, she never denied the fact that he was often a jerk. And while some of the things Richard does are far from admirable and his justification for those actions is certainly twisted, his reasons also make him not irredeemable. I could believe that he would grow and become a better person. This is a sweet, clean novella. While I noticed one or two errors, the editing is also decent. I received an ARC from the author. I was not required to write a review, but chose to do so and the opinions stated are my own.

I really enjoyed Ms. Kingsley's debut very much. This book was well written. The characters

development was done well and the story had a happy ending. There were no sex scenes to navigate and the language was clean. This was kind of a modern day Beauty and the Beast story. Richard DeMarco was a very wealthy, but ruthless, businessman. He was heartless and felt that he had to be that way to be successful. Grace was hired as his in-house attorney. She needed this well paying job to pay back some debt her parents had accumulated helping to support her education dreams. She really would rather work for an environmentally conscious company but she could do anything for a short time to earn the money she needed. She just didn't think this job was as horrible as it turned out to be. She began to see a softer side of Richard DeMarco and then he showed "his true colors", or at least the colors he wanted his employees and the world to see. He was determined to harden Grace to the ways of the world and by doing that he would show her how much he cared for her. That would protect her from being hurt, or so he thought. I won't give away the ending but it was satisfying. I was given a complimentary copy of this book in exchange for an honest review.

This is a clean inspirational romance with two strong characters each series about their own values and beliefs. Fresh out of law school, Grace takes a job with the ruthless billionaire businessman Richard DeMarco. She had reservations about working for him, but she needed the money to help her parents with bills and to pay off her student loans. There is a definite attraction between the two but there are struggles as she tries to retain her values while he tries to mold her into his. A really good read that is well written with interesting characters and a strong story line. I voluntarily chose to review this book which was given to me as an advance copy.

I can't believe that this is the author's first novel. It is well polished, the characters are well fleshed out, the moral message is strong and the plot is exceptionally well done.
